

# Fee schedule 2020

Children are enrolled at Torrens Valley Christian School (TVCS) on the understanding that parents have committed to pay all fees when they are due. We seek to keep fees as low as economically possible and therefore we ask that fees are paid by the due dates.

## Application Fee

A non-refundable Application Fee of \$100 per family is required at the time of lodging an Application for Student Enrolment.

## Entry Deposit

A \$500 refundable Entry Deposit is required prior to a student commencing tuition. Concessions are available to families starting more than one child at the same time.

The Entry Deposit is refunded upon completion of schooling at TVCS, provided there is no debt owed to the school and one term's signed written notice has been provided. If a term's notice is not given, a term's fees will be charged.

## Annual Tuition Fees

This table sets out the Tuition Fee Schedule for students enrolled at Torrens Valley Christian School. The schedule shows the fees for families and those for State Government approved School Card holders. Tuition fees incorporate the costs of all text books, student stationery, laptops, secondary school ID cards, compulsory year-level camps and excursions.

Sibling discounts apply to siblings currently attending school.

A 5% discount applies if the full year fees are paid by Friday 14 February 2020.

# Fee schedule 2020

## Payment Arrangements

Invoices for tuition fees are invoiced annually in late January or upon acceptance of your enrolment thereafter. Tuition fee payments are made via FACTS Management Australia online self-service portal via an automatic payment schedule from your bank account or credit card. FACTS payment schedule options are:

- Annually (single payment due by 14 February 2020 – 5% discount applies)
- Weekly
- Fortnightly
- Monthly
- Three instalments

Tuition fees must be paid over the course of the year according to the chosen FACTS payment schedule. All payment plans conclude no later than 30 November. Families who have not previously registered or set up a FACTS account will receive an email link in November to complete registration and select a payment plan. FACTS accounts need to be set up by 20 December 2019. Late enrolments or enrolments through the year will receive an email link to register upon acceptance. If your employer offers you the option to salary sacrifice tuition fees, please contact the Finance Office to discuss payment arrangements.

## State Government School Card

Families who believe they qualify for State Government School Card must complete the appropriate application form each year as early as possible in the school year. Application forms are generally available from early January via SA.GOV.AU. Forms are to be submitted as per the instructions on the applicable form. Note: Torrens Valley Christian School is classified as an Independent non-government school with reference to income limit eligibility. Tuition fees will be invoiced at the full rate until official notification of eligibility is received by the School, and then the School will apply the School Card Discount.

## Building Fund Donation

It is an economic fact that, to maintain and develop the School's buildings we depend on donations to our Building Fund. The 2020 Building Fund donation is \$800 per family and \$400 for families on School Card. Payments for Building Fund Donations can be made via a FACTS payment form and a link is available on the school's website: tvcs.sa.edu.au.

To obtain tax-deductible status, donations must be made voluntarily and separate receipts will be issued.
